OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited by law and outside the United States. Subject to all federal, state and local laws, regulations, and ordinances. Sweepstakes begins on September 1, 2026 at 12:00:01 a.m. Central Time (“CT”) and ends on January 10, 2027 at 11:59:59 p.m. CT (the “**Sweepstakes Period**”). Sponsor’s computer is the official time keeping device for this Sweepstakes.

ELIGIBILITY: The Lambeau to your Living Room Sweepstakes (the “**Sweepstakes**”) is open to legal U.S. residents currently residing in Wisconsin to enter to win who are at least 18 years old to win the sweepstakes. purpose of marketing and informational purposes (by direct message, tagging you, posting to your social media page(s) or naming you on Sponsor's social media page(s)), even if your number or email is currently listed on any state, federal or internal Do No Call List. Normal access, phone, and usage charges imposed by your telephone, email or internet provider may apply.

Please note: By entering in this Sweepstakes, you signify and agree that your Entry Form and any other materials submitted in connection with this Sweepstakes may be posted on Sponsor's website and/or other social media sites or applications associated with the Sweepstakes in a manner that is consistent with these Official Rules. Upon submission of entry in this Sweepstakes, you agree that Sponsor may contact you via social media, including on Facebook or Instagram by sending you a direct message, tagging you, posting to your social media page(s) or naming you on Sponsor's social media page(s). Limit one (1) entry per person/email address. You must accurately provide all required information to be eligible to enter and win. All potential winners are subject to verification before any prize will be awarded.
